RESTORATION ADVISORY BOARD TO BE ESTABLISHED AT THE FORMER SCHENECTADY ARMY DEPOT, VOORHEESVILLE

As part of the U.S. Army Corps of Engineers' (Corps) citizen participation program at the Former Schenectady Army Depot (Depot), a Restoration Advisory Board (RAB) will be established to enhance information sharing and decision making. The RAB's primary goals will be the following:

- Provide members of the community with a forum for reviewing and following Depot investigations and results.
- Provide a forum for assessing alternative remediation strategies to address site contamination.
- Provide an educational forum for understanding former, current, and future activities on the Former Schenectady Army Depot site.

The Corps' decision to form the RAB came after the November 19, 1998 public meeting in which several attendees from the community expressed an interest in participating in RAB activities. Currently, the RAB consists of approximately ten members. Anyone interested in joining or attending RAB meetings is welcome. The first meeting will be held on June 23, 1999 at the Voorhesville Public Library from 6:30 p.m. - 8:30 p.m.

The Depot RAB will consist of community volunteers, representatives of local businesses, and government (municipal, state, and federal) officials who will meet to better understand Corps activities, provide recommendations, and act as the liaison with the community as a whole.

The RAB will serve as a forum for discussing and exchanging information on matters related to the investigation and cleanup of environmental and public health hazards at Formerly Used Defense Sites such as the Former Schenectady Army Depot. The RAB will review reports, make recommendations on what, if any, further action is needed, and help to set remediation priorities.

The RAB will meet as necessary, but usually on a quarterly basis. The meetings are open to the public.

NEW DOCUMENT IN PROJECT REPOSITORIES

The U.S. Army Corps of Engineers has recently published a *Final Draft Report of Findings*. This document describes the results of recent groundwater/surface water sampling at the Former Schenectady Army Depot – Voorheesville (FSADV). The sampling was conducted as part of an ongoing investigation into Department of Defense activities at the former Depot.

Specifically, the sampling focused on groundwater at the site, and suface water and sediments of Black Creek which flows along the eastern border of the former Depot.

Results of the surface water sampling from Black Creek were compared to the ambient water quality standards listed by the New York State Department of Environmental Conservation (NYSDEC). These samples indicate that there appears to be a limited impact on the quality of the surface water within Black Creek. Only lead and 1,1,2,2-tetrachloroethane were detected above state standards in a few of the sampling locations. Based on the samples taken, it appears that the source(s) of the contamination may be upstream of the site, but further testing will be necessary to verify this

Analysis of Black Creek sediment samples indicates

that metals are present in the sediments of Black Creek; including cadmium, copper, iron, nickel, and zinc.

Further background and upstream sampling will help determine if the metals came from the site. If it is determined that the metals came from the site, and are the result of past DoD activities, then a Risk Assessment/Ecological Study will be conducted to evaluate the remediation.

The Final Draft Report of Findings is available for review at both project repositories.

Another document in the final stages of preparation is the *Investigation Report – Archival Search, Former Schenectady Army Depot – Voorheesville Area.* This report is the product of research and analysis efforts that the Corps has conducted in order to find out more about the past activities and operations at the Depot. The report traces the history of the site and identifies past military activities that may relate to potential site contamination.

This report is expected to be in the project repositories within the next few weeks.
