Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain:

There are two isolated wetlands, Wetlands D and Z, within the site boundary, totaling 0.07 acres. The closest of these isolated wetlands to any jurisdictional waters is Wetland D, which is approximately 72 linear feet from the nearest jurisdictional wetland located to the south. Both wetlands are small depressional wetlands, surrounded by upland vegetation and upland soils, and fail to show any hydrological connection to any jurisdictional wetland. Both wetlands are located within an old logging skid trail. There are no man-made or natural discrete and/or confined surface water connection between any of the two wetlands and any jurisdictional water of the United States. Neither of the wetlands is located within a mapped 100-year flood plain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject wetlands. Neither of the wetlands would be considered a traditional navigable water in that they do not have the necessary water depth to support navigation of any kind, and they do not have any surface hydrologic connection to a waterbody that would. The wetlands do not cross any state boundary and do not have a use that would associate them with interstate commerce.
