These wetlands appear to be isolated from the tributary system and have no significant nexus to the tributary system**

that would make them jurisdictional. The closest jurisdictional wetland is located approximately 80 feet from these wetlands. The closest downstream tributary is an unnamed tributary to Beaver Meadow Creek, which is located over 5,000 feet south of these wetlands and is situated in a wide ravine over 10 feet below the lowest ground surface elevation within these wetlands. Given the separation distance and the elevation change; these wetlands would not be considered neighboring, or otherwise providing any measurable benefit to the biological, physical, or chemical quality of the tributary or any water of the United States. No evidence of any past connections between this wetland and any other surface waterbody was observed. There is no man-made or natural discrete and/or confined surface water connection between the wetland and any other jurisdictional water. The wetland is not located within a mapped 100-year flood plain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject wetlands. These wetlands would not be considered a traditional navigable water in that they do not have the necessary water depth to support navigation of any kind. These wetlands do not cross any state boundary and they do not have a use that would associate them with interstate commerce.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

jurisdictional. The closest jurisdictional wetland is located approximately 200 feet from these wetlands. The closest downstream tributary is an unnamed tributary to Beaver Meadow Creek, which is located over 5,000 feet south of these wetlands and is situated in a wide ravine over 10 feet below the lowest ground surface elevation within these wetlands. Given the separation distance and the elevation change; these wetlands would not be considered neighboring, or otherwise providing any measurable benefit to the biological, physical, or chemical quality of the tributary or any water of the United States. No evidence of any past connections between this wetland and any other surface waterbody was observed. There is no man-made or natural discrete and/or confined surface water connection between the wetland and any other jurisdictional water. The wetland is not located within a mapped 100-year flood plain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject wetlands. These wetlands would not be considered a traditional navigable water in that they do not have the necessary water depth to support navigation of any kind. These wetlands do not cross any state boundary and they do not have a use that would associate them with interstate commerce.

Explain: **Wetland c is a small shallow depressional areas within a maneuver corridor that was likely created as a result of the historic operation of military equipment, including tracked vehicles. This wetland appears to be isolated from the tributary system and has no significant nexus to the tributary system that would make it jurisdictional. The closest**

jurisdictional wetland is located approximately 200 feet from this wetland. The closest downstream tributary is an unnamed tributary to Beaver Meadow Creek, which is located over 5,000 feet south of this wetland and is situated in a wide ravine over 10 feet below the lowest ground surface elevation within this wetland. Given the separation distance and the elevation change; this wetland would not be considered neighboring, or otherwise providing any measurable benefit to the biological, physical, or chemical quality of the tributary or any water of the United States. No evidence of any past connections between this wetland and any other surface waterbody was observed. There is no man-made or natural discrete and/or confined surface water connection between the wetland and any other jurisdictional water. The wetland is not located within a mapped 100-year flood plain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject wetland. This wetland would not be considered a traditional navigable water in that it does not have the necessary water depth to support navigation of any kind. This wetland does not cross any state boundary and it does not have a use that would associate it with interstate commerce.

C. SIGNIFICANT NEXUS DETERMINATION

C. SIGNIFICANT NEXUS DETERMINATION
