The use, degradation or loss of Pond 6 will not affect other waters of the U.S.

There is no apparent surface connection to other waters, as Pond 8 is located approximately 600 feet from the nearest water of the United States (Tenmile River), so Pond 8 does not appear to contribute flow to downstream waters, nor does it appear to export organic matter. There are no areas within Pond 8 from which fish or shellfish can be or are taken and there are no signs that any features of this wetland contribute to the life cycles or aquatic habitat of species within (a)(1), (a)(2) or (a)(3) waters. The use, degradation or loss of Pond 8 will not affect other waters of the U.S.
