EXTENSION OF PUBLIC COMMENT PERIOD

To Whom It May Concern:

On October 2, 2013, the New York District Corps of Engineers issued Public Notice Number NAN-2009-01089-EYA describing an application for Department of the Army authorization submitted by Champlain Hudson Power Express, Inc. to construct a 332.8 mile long high voltage direct current electric transmission system between Canada and Queens, New York.

On October 11, 2013, the New York District Corps of Engineers issued Supplemental Public Notice No. 1 as notification that due to the lapse in appropriations resulting in the current Federal government shutdown, the lead Federal Agency for this project, the US Department of Energy, has postponed the public hearings previously scheduled for this project as announced in the Public Notice from this office issued on October 2, 2013.

On October 21, 2013, the New York District Corps of Engineers issued Supplemental Public Notice No. 2 as notification that the US Department of Energy has rescheduled the public hearing dates. Due to the rescheduled Public Hearings dates, the New York District Corps of Engineers will extend the project's public comment period to November 30, 2013.


On November 5, 2013, the New York District Corps of Engineers issued Supplemental Public Notice No. 3 as notification that the US Department of Energy has scheduled the public comment period for the project's draft Environmental Impact Statement (DEIS) to end on December 16, 2013. To correspond with the DEIS public comment period, the New York District Corps of Engineers will extend the public comment period for Public Notice NAN-2009-01089-EYA to December 16, 2013.

This Supplemental Public Notice No. 4 is being issued as notification that the US Department of Energy has scheduled the public comment period for the project's draft Environmental Impact Statement (DEIS) to end on January 15, 2014. To correspond with the DEIS public comment period, the New York District Corps of Engineers will extend the public comment period for Public Notice NAN-2009-01089-EYA to January 15, 2014.
