<b>NY &amp; NJ CHANNELS - PERTH AMBOY ANCHORAGE</b> <ul style="list-style-type: none"> <li><b>Reach U (Perth Amboy Anchorage) Area No. 1</b> – Shoaling exists throughout much of the reach, with authorized depth available in the southeast portion of the anchorage. The controlling depth of -22.5 feet MLLW is located approximately 250 feet north of YELLOW CAN "B" EBB.</li> <li><b>Reach U (Perth Amboy Anchorage) Area No. 2</b> – Shoaling exists in the western portion of this reach. The controlling depth of -21.6 feet MLLW is located along the limit of the anchorage, approximately 310 feet northwest of YELLOW CAN "A" EBB.</li> <li><b>Reach U (Perth Amboy Anchorage) Area No. 3</b> – No shoaling exists in this reach. The controlling depth of -39.4 feet MLLW is located approximately 165 feet southwest of GREEN #55 W/LIGHT EBB.</li> <li><b>Reach U (Perth Amboy Anchorage) Area No. 4</b> – Shoaling exists throughout the majority of this reach. The controlling depth of -31.1 feet MLLW is located approximately 795 feet northeast of GREEN FIXED AID W/LIGHT.</li> </ul>
