#### SHOALING BY REACHES:

## Reach M – Outerbridge Reach:

- o Edge shoaling exists intermittently along the Left and Right Outside Quarters of this reach.
- The controlling depth of -33.6 feet exists in the Right Outside Quarter approximately 740 feet seaward of RED #2 W/LIGHT EBB. It also exists in three locations in the Left Outside Quarter approximately 1110 feet seaward and 1655 feet landward of RED #2 W/LIGHT EBB and 260 feet seaward of GREEN #5 W/ LIGHT FLOOD.

#### Reach N - Ward Point Bend West Reach:

- o Shoaling exists across the Right Outside Quarter, Right Inside Quarter and into the Left Inside Quarter.
- o Sporadic shoaling exists in the Left and Right Outside Quarters of this reach.
- The controlling depth of -31.5 feet exists in the Right Outside Quarter approximately 395 feet seaward of RED BEACON #58.

## Reach O - Ward Point Bend East Reach:

- Edge shoaling exists intermittently along the Left and Right Outside Quarters of this reach.
- The controlling depth of -27.6 feet exists in the Left Outside Quarter approximately 745 feet landward of GREEN #47 W/LIGHT FLOOD.

#### Reach P - Red Bank Reach:

- o Minor edge shoaling exists intermittently along the Left and Right Outside Quarters of this reach.
- The controlling depth of -32.8 feet exists in the Left Outside Quarter approximately 195 feet seaward of the end of this reach.

# Reach Q – Seguine Point Bend Reach:

- Shoaling exists along the channel toe of the Right Outside Quarter as well as the Left Outside Quarter extending into the Left Inside Quarter of this reach.
- The controlling depth of -16.6 feet exists in the Right Outside Quarter approximately 905 feet landward of RED #30 W/LIGHT EBB.
