Draft Integrated Feasibility Report and Environmental Impact Statement Notice of Availability for the Rahway River Flood Risk Management Study

The U.S. Army Corps of Engineers, New York District in partnership with New Jersey Department of Environmental Protection announces the availability of the Draft Integrated Feasibility Report and Environmental Impact Statement (DIFR/EIS) for the Rahway River Flood Risk Management Study, Rahway, N.J. for a 45-day public comment period, in which the general public can submit comments regarding the report.

This Draft Integrated Feasibility Report and Environmental Impact Statement has been prepared to document the formulation and evaluation of plans to address flooding problems in the Rahway River Basin and the significance of potential environmental impacts of the Tentatively Selected Plan (TSP) recommended in the report.

The TSP consists of two alternative project elements in three different areas in the circumference of the Rahway River Basin: Alternative 4a, which includes channel improvements in Cranford, N.J. and modification to the Orange Reservoir Dam spillway in West Orange, N.J., and Alternative 2a, which is a non-structural plan in the 10-year floodplain for the Robinson's Branch in the City of Rahway, N.J. The TSP provides various levels of flood risk management to the Townships of Cranford, Springfield, Millburn, and the City of Rahway.
