C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- Other: (explain, if not covered above): There are two isolated wetlands, Wetlands 1 and 2, within the JD boundary. Both appear to be man-induced within an apple orchard. Evidence of excavation to the north of Wetland 1 was found during the site inspection. Wetland 1 is 0.13 acres and Wetland 2 is 0.05 acres. Uplands of a higher elevation surround both of these wetlands. Wetland 2 is located approximately 36 feet to the north of a large wetland complex. The uplands between them are 1.5 feet higher than the elevation of the wetlands. There are no man-made or natural surface water connections between Wetlands 1 and 2, and none between these wetlands and the large wetland complexes seen on the map to the south and further to the west, nor to any other known waters of the United States. Wetlands 1 and 2 are not located within a mapped 100 year floodplain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject wetlands. The wetlands would not be considered traditional navigable waters in that they do not have the necessary water depths to support navigation of any kind, and they do not have any surface hydrologic connection to a waterbody that would. The wetlands do not cross any state boundary and do not have a use that would associate them with interstate commerce.
