### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- Other: (explain, if not covered above): **There are four isolated wetlands, Wetlands 2, 3, 4 and 5, within the JD boundary. All four are situated within agricultural lands. Wetland 2 is 1.97 acres within the JD boundary and is located approximately 219 feet away from, and 10 feet higher in elevation than the nearest jurisdictional waters. Although Wetland 2 extends off-site to the west, the wetland ends just outside of the property boundary and the topography increases in that direction. Wetlands 3, 4, and 5 are located entirely on-site, and are 0.05, 0.22, and 0.05 acres in size, respectively. These wetlands are located at least 65 feet away from their nearest jurisdictional waters. Uplands that are 1.5 feet higher in elevation separate Wetland 3 from the nearest jurisdictional waters. Like Wetland 2, Wetlands 4 and 5 are situated at an elevation at least four feet higher than the nearest jurisdictional waters. There are no man-made or natural surface water connections between Wetlands 2, 3, 4 and 5 and any jurisdictional waters of the United States. There is no evidence of any disturbance that could have caused these wetlands to become disconnected from their nearest jurisdictional waters. Wetlands 2, 3, 4 and 5 are not located within a mapped 100 year floodplain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject wetlands. The wetlands would not be considered traditional navigable waters in that they do not have the necessary water depths to support navigation of any kind, and they do not have any surface hydrologic connection to a waterbody that would. The wetlands do not cross any state boundary and do not have a use that would associate them with interstate commerce.**

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. If the JD covers a tributary with adjacent wetlands, complete Section III.B.1 for the tributary, Section III.B.2 for any onsite wetlands, and Section III.B.3 for all wetlands adjacent to that tributary, both onsite and offsite. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
