Explain: **The isolated wetland areas depicted as A, B and C and within the project area were determined not to be jurisdictional because they are isolated. These isolated wetlands are located at a higher elevation. The general**

location of the isolated wetlands under review are not depicted on the U.S. Fish and Wildlife Service Wetland Inventory Maps, or the New Jersey Department of Environmental Protection Wetland Maps. Wetland Area A, is a wetland depression. There are no apparent overland flow routes or culverts entering or exiting Wetland A. Both Wetland Areas B and C are storm water detention basins that have not been maintained. Culverts which allow storm water to enter the basin from the adjacent road are located at each end of the basins, however, there are no culverts present which convey surface storm water from the basins to other adjacent waterways. Therefore, Wetland Areas A, B, and C were determined to be isolated.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

There was no apparent overland flow routes or culverts entering or exiting Wetland A. There are no culverts within Wetland B and C which convey surface storm water from these areas to other adjacent waterways. There were no features within Wetland Areas A, B or C that are or could be used by interstate or foreign travelers for recreational or other purposes. There are no areas from which fish or shellfish are or could be taken and sold in interstate or foreign commerce. There are no areas which are or could be used for industrial purposes by industries in interstate commerce. Consequently, there does not appear to be a reasonable nexus with interstate commerce. Also, the use, degradation or loss of Wetland Areas A, B and C will not affect other waters of the U.S. or affect interstate or foreign commerce.**
