### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** In reference to Section III.D.7 above, the 0.22 acre open water area, or pond, on the site was created by impounding existing waters of the United States. Wetlands continue to exist both above and below the pond. There is a pipe within the impoundment that continues to provide a surface connection between the pond and higher elevation wetlands to the downstream wetlands and waters. This outflow becomes more confined off-site and becomes an unnamed tributary to Ballston Creek. Mapping of the stream off-site, including the USGS Quadrangle, indicates that the unnamed tributary is perennial.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. Other: (explain, if not covered above): **There are four isolated wetlands, identified as Wetlands 3, 4, 5 and 6, that total 0.15 acre within the jurisdictional determination boundary. All four are currently forested depression wetlands, which may have been man-induced from historic agricultural activities on the site. The wetlands are located a minimum of 70 feet away from the closest jurisdictional waters. All four wetlands are higher in elevation than their nearest jurisdictional waters and have natural upland barriers between them. All four wetlands are located entirely within the limits of the jurisdictional determination and do not extend off-site. There are no natural or man-made discrete or confined surface hydrological connections between the four isolated wetlands and their nearest jurisdictional waters. There does not appear to be any potential for ecological interconnections or shallow subsurface flow between the isolated wetlands and their nearest jurisdictional waters. The site is not located within a mapped 100 year floodplain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject wetlands. The wetlands would not be considered traditional navigable waters in that they do not have the necessary water depths to support navigation of any kind, and they do not have any surface hydrologic connection to a waterbody that would. The wetlands do not cross or serve as any state boundary and do not have a use that would associate them with interstate commerce.**
