C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

 - Other: (explain, if not covered above): **There are two isolated wetlands, identified as Wetlands 4 and 5, that total 0.17 acre within the jurisdictional determination boundary. The wetlands are located a minimum of 65 feet away from the closest jurisdictional waters. Wetland 4 is 7 feet higher in elevation than the nearest jurisdictional waters and is situated entirely within the property boundary. Wetland 5 is lower in elevation than the nearest jurisdictional water, and a small portion of it extends off-site. Its off-site terminus was visible and evident during the USACE site inspection. For both wetland areas, they are surrounded by uplands that have not been manipulated to cause them to be disconnected from any jurisdictional waters. There are no natural or man-made discrete or confined surface hydrological connections between the two isolated wetlands and any jurisdictional waters. Both wetlands appear to be natural depression wetlands. Wetlands 4 and 5, and the entire property, are not located within a 100 year floodplain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject wetlands. The wetlands would not be considered traditional navigable waters in that they do not have the necessary water depths to support navigation of any kind, and they do not have any surface hydrologic connection to a waterbody that would. The wetlands do not cross or serve as any state boundary and do not have a use that would associate them with interstate commerce.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW.
