### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

  - Other: (explain, if not covered above): **There are six wetlands, Wetlands E, F, D, I, J and K, within the JD boundary, and measure 0.05 acre, 0.03 acre, 0.12 acre, 0.08 acre, 0.07 acre, and 0.03 acre, respectively. Wetlands D, I, J and K appear to be man induced as a result of over-excavating or over-compacting when removing fill material to restore an area that was briefly an access road back into agricultural lands. Wetlands E and F are located within an agricultural field. All of these wetlands are emergent and have similar vegetation, including Lythrum salicaria, Onoclea sensibilis and Impatiens capensis. Five of these wetlands are located entirely within the property boundary. Wetland I extends off-site to the northeast within the same agricultural field, however, it was clear to see where the wetland ended during the USACE site inspection. Half of this wetland is on-site. The elevation of Wetland I increases to the northeast off-site, so it drains on-site toward the southwest. Each of the six isolated wetlands are depressions that are surrounded by slightly higher elevations, and are overall higher in the landscape than their nearest jurisdictional waters. There are no natural or man-made surface water connections between these wetlands and any waters of the United States. These wetlands are located between 50 feet and 260 feet away from the nearest known waters of the United States. Although portions of the site within the JD boundary do lie within the FEMA mapped 100 year floodplain, none of six isolated wetlands are located within the 100 year floodplain. Therefore, during times of heavy precipitation, there is very low probability that that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject wetlands. The six isolated wetlands would not be considered traditional navigable waters in that they do not have the necessary water depths to support navigation of any kind, and they do not have any surface hydrologic connection to a waterbody that would. These six wetlands do not cross any state boundary and do not have a use that would associate them with interstate commerce.**
