C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

 - Other: (explain, if not covered above): **Wetland 2 (shown of the wetland drawing as Wetlands 5 and 6) is approximately 0.53 acre in size and both wetlands are located within topographical depressions, which have no discernible inlets or outlets. Wetland 2 is encompassed by upland soils and non-hydrophytic vegetation. Wetland 2 does not appear to be connected to a surface tributary system associated with a navigable waterway. No evidence of any past natural or manmade connections between Wetland 2 and any other waters were observed. The site is not located within a mapped 100-year floodplain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject wetland. The wetland would not be considered a traditional navigable water in that it does not have the necessary water depth to support navigation of any kind, and does not have any surface hydrologic connection to a waterbody that would. Wetland 2 does not cross or serve as any state boundary and does not have a use that would associate it with interstate commerce. Wetland 2 is located at least 20 feet from the closest jurisdictional water, Wetland 1. An elevation change of at least a 2 feet prevents drainage exchange between Wetland 1 and 2. Wetland 3 (shown of the wetland drawing as Wetland 2) is 0.34 acre in size, within the property boundary. Wetland 3 appears to have formed as a result of past excavation and tree clearing activities that have taken place on the site and is surrounded on three sides by an on-site berm. Wetland 3 drains west to an off-site catch basin associated with the Town of Bethlehem's storm drainage system. During significant snow melt and/or precipitation events, drainage from within Wetland 3 may to enter the storm drainage system. The system the does ultimately drain to the Hudson River, however, the drainage flows through well over 12 miles of storm system, open drainage swale and tributaries before entering the Hudson River. The drainage system does not appear to have replaced a natural tributary system. Wetland 3 is located is not abutting nor adjacent to a jurisdictional waters of the United States and is therefore considered isolated.**
