C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- Other: (explain, if not covered above): **There are two wetland areas, identified as Wetlands D and E, that total 0.07 acre within the property boundary. Wetlands D and E are in close proximity to each other and are depicted on Sheet 2 of 3 of the wetland delineation drawings. Both wetlands are located entirely within the limits of the jurisdictional determination and do not extend off-site. Both wetlands are emergent and are located in areas previously used for agriculture. Wetlands D and E are located a minimum distance of 160 feet from its nearest jurisdictional waters, and there are no natural or man-made discrete or confined surface hydrological connections between them. Both wetlands are surrounded by uplands and there is no evidence of any historic disturbances that could have caused these wetlands to become disconnected from any waters of the United States. There also does not appear to be any potential for ecological interconnections or shallow subsurface flow between the isolated wetlands and their nearest jurisdictional waters. The site is not located within a mapped 100 year floodplain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject wetlands. The wetlands would be not considered traditional navigable waters in that they do not have the necessary water depths to support navigation of any kind, and they do not have any surface hydrologic connection to a waterbody that would. The wetlands do not cross or serve as any state boundary and do not have a use that would associate them with interstate commerce.**

C. SIGNIFICANT NEXUS DETERMINATION
