C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- Other: (explain, if not covered above): **There are five isolated wetlands within the jurisdictional determination boundary.**

These wetlands are identified as Wetlands 1, 4, 7, 8 and 9 on the referenced wetland delineation drawing and consist of a total of 1.05 acres within the site boundary. Wetlands 4, 7, 8 and 9 were previously determined to be isolated and non-jurisdictional in an approved jurisdictional determination issued by the New York District, U.S. Army Corps of Engineers on September 23, 2009. All five of these wetlands are forested depressional wetlands. Wetlands 7, 8 and 9 are located entirely on the project site. Wetland 4 extends off-site but terminates less than 15 feet to the south. Wetland 1 terminates to the east at Dunsbach Road. On the opposite side of the road, there is a wetland area of similar size. Either on or off site, this wetland does not continue nor does it connect with any waters of the United States. Uplands surround all of these wetlands, and none are located less than 50 feet from any jurisdictional waters. There are no natural or man-made surface connections between these five wetlands and any jurisdictional waters, nor is there any evidence of any prior activities that could have caused these wetlands to become disconnected from jurisdictional waters. There does not appear to be any potential for ecological interconnections or shallow subsurface flow between the 5 isolated wetlands and their nearest jurisdictional waters. The site is not located within a mapped 100 year floodplain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject wetlands. The wetlands would not be considered traditional navigable waters in that they do not have the necessary water depths to support navigation of any kind, and they do not have any surface hydrological connection to a waterbody that would. The wetlands do not cross or serve as any state boundary and do not have a use that would associate them with interstate commerce.

Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
