### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Other: (explain, if not covered above): **Wetlands 3 and 4 are two man-induced wetlands, formed as a result of mining that historically occurred in this portion of the property. The wetlands combine for a total 0.02 acre. Both are located entirely within the property boundary. Wetlands 3 and 4 are surrounded by uplands that are at least four feet higher in elevation than the wetlands. These two wetlands are located even higher in the landscape, and well over 400 feet from the nearest known waters of the United States. There are no natural or man-made discrete or confined surface hydrological connections between the two isolated wetlands and the nearest known waters of the United States. Wetlands 3 and 4 are not located within a mapped 100 year floodplain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject wetlands. The wetlands would not be considered traditional navigable waters in that they do not have the necessary water depths to support navigation of any kind, and they do not have any surface hydrologic connection to a waterway that would. The wetlands do not cross or serve as any state boundary and do not have a use that would associated them with interstate commerce.**
