C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

 Other: (explain, if not covered above): **Wetland A is approximately 0.29 acre in size and is located within a topographical depression which has no discernable inlet or outlet. Wetland A is encompassed by upland soils and non-hydrophytic vegetation. Wetland A does not appear to be connected to a surface tributary system associated with a navigable waterway. No evidence of any past natural or manmade connections between Wetland A and any other waters were observed. The site is not located within a mapped 100-year floodplain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject wetland. The wetland would not be considered traditional navigable water in that it does not have the necessary water depth to support navigation of any kind, and does not have any surface hydrologic connection to a waterbody that would. The wetland does not cross or serve as any state boundary and does not have a use that would associate it with interstate commerce. The boundary of Wetland A extends northeast off of the project site about 25 feet and then terminates. Wetland A is located at least 7,000 feet away from the closest jurisdictional water, the Normans Kill.**
