C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- Other: (explain, if not covered above): **There are three isolated wetlands, identified as Wetlands A, B1 and B2 on the delineation drawing, that consist of a total of 3.091 acres within the jurisdictional determination boundary. Wetlands A and B1 are located entirely within the jurisdictional determination boundary within the 14 Tait Lane, LLC, parcel. These wetlands are man-induced, formed by recent over-excavation at the site to prepare it for a storage facility development that was never built. Evidence from a report that was prepared for the storage facility development suggests that this particular parcel was uplands before the site clearing and partial grading occurred. Both wetlands are in depressions with higher elevations surrounding them, including an over 15 foot high embankment that supports State Route 9N to the north. There are no man made or natural surface hydrological features, including road ditches, that could connect these wetlands to any jurisdictional waters. The nearest known jurisdictional waters in relation to Wetlands A and B1 are over 900 feet to the east. Wetland B2 is a naturally occurring wetland within the Denton Road, LLC, parcel, but has been disturbed by past development, including the installation of a municipal water line and historic farming. Wetland B2 extends off-site to the north and east. To the north, it ceases just off of the site due to a natural abrupt change in topography. To the east, the wetland ceases just before a berm that supports actively used and maintained railroad tracks. There are no natural or man-made surface hydrologic connections between Wetland B2 and any jurisdictional waters. During the site inspection conducted on July 30, 2014, the lands on the east side of the railroad tracks were also inspected. The closest wetland to Wetland B2 would have been a wetland that was previously determined to be an isolated wetland and not waters of the United States by the USACE by letter dated April 26, 2011. This wetland has since been filled in. Beyond that, the nearest known jurisdictional water is a wetland located over 400 feet to the east of Wetland B2. In between, there are the railroad tracks and an access road to a railroad station. There are however, undeveloped uplands between these wetlands as well. No culverts, ditches or other features were found that could connect these two wetland areas. Despite the development that occurred between these two wetlands, there is no evidence to suggest that these wetlands were ever connected to one another. To the west and south, Wetland B2 is bound by uplands that are at least two feet higher in elevation. There does not appear to be any potential for ecological interconnections or shallow subsurface flow between the three isolated wetlands and their nearest jurisdictional waters. The site is not located within a mapped 100 year floodplain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject wetlands. The wetlands would not be considered traditional navigable waters in that they do not have the necessary water depths to support navigation of any kind, and they do not have any surface hydrologic connection to a waterbody that would. The wetlands do not cross or serve as any state boundary and do not have a use that would associate them with interstate commerce.**
