C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- Other: (explain, if not covered above): **There are eighteen (18) isolated wetlands, identified as Wetlands 3 through 20 on the referenced wetland delineation map, within the limits of the jurisdictional determination that total 0.91 acres. None of these wetlands extend off-site. On August 30, 2010, the New York District of the U.S. Army Corps of Engineers issued an approved jurisdictional determination confirming that Wetlands 3 through 19 are isolated and not considered to be waters of the United States. Wetland 20 is a newly identified wetland located in the western portion of the site. All of these wetlands appear to be naturally occurring and are primarily depressional wetlands within a forest. Wetlands 11 and 15 are more sloping. The isolated wetlands range in distances between 21 feet and 233 feet from the nearest jurisdictional waters, which are wetlands. The distances between the isolated wetlands and surface tributaries are greater. All of the isolated wetlands are encompassed by uplands that are predominantly 3 feet or more higher in elevation than the nearest jurisdictional waters. There are no natural or man-made surface features that connect the 18 isolated wetlands to their nearest jurisdictional waters, nor are there any indicators of prior site disturbances that could have caused any of the isolated wetlands to become disconnected from the nearest jurisdictional waters. Neither this site, nor these wetlands, are located within a mapped 100 year floodplain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject wetlands. The wetlands would not be considered traditional navigable waters in that they do not have the necessary water depths to support navigation of any kind, and they do not have any surface hydrologic connection to a waterbody that would. The wetlands do not cross or serve as any state boundary and do not have a use that would associate them with interstate commerce.**
