### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

### C. SIGNIFICANT NEXUS DETERMINATION

The amount of non-jurisdictional waters on this site is being reduced from the February 23, 2009, jurisdictional determination because areas previously identified as wetlands no longer meet the criteria set forth in the 1987 Wetland Delineation Manual and subsequent guidance. Wetlands C and D are depressional wetlands located within a forested area. These wetlands are minimum of 280 feet from their nearest jurisdictional waters, which are wetlands, and at least 550 feet away from the nearest tributary. Both of the isolated wetlands are encompassed by uplands that are at least 3 feet higher in elevation than the nearest jurisdictional waters. There are no natural or man-made surface features that connect the two isolated wetlands to their nearest jurisdictional waters, nor are there any indicators of prior site disturbances that could have caused these isolated wetlands to become disconnected from the nearest jurisdictional waters. Neither this site, nor these wetlands, are located within a mapped 100 year floodplain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject wetlands. The wetlands would not be considered traditional navigable waters in that they do not have the necessary water depths to support navigation of any kind, and they do not have any surface hydrologic connection to a waterbody that would. The wetlands do not cross or serve as any state boundary and do not have a use that would associate them with interstate commerce.**
