### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

These forested wetlands are a mixture of naturally occurring and man-induced. Wetlands 4, 5, 8 and 10 are located entirely within the site boundary. Of those, only Wetland 4 appears to be naturally occurring. Higher elevation uplands surround each of these wetlands and there is no natural or surface hydrological connection between these wetlands and any waters of the United States. Wetlands 6, 7 and 9 extend off-site. The USACE was able to confirm that the off-site portions of these wetlands do not continue and become physically connected to any jurisdictional waters. Wetlands 6 and 7 slope into the subject site. Wetland 9 is a depression. These three wetlands are also surrounded by higher elevation uplands and have no natural or man-made surface hydrologic connection to any waters of the United States. For all seven of these wetlands, there is no evidence that any prior disturbance could have caused these wetlands to be disconnected from jurisdictional waters. All of these wetlands are located between 100 feet and 725 feet from the nearest jurisdictional waters. There does not appear to be any potential for ecological interconnections or shallow subsurface flow between the seven isolated wetlands and their nearest jurisdictional waters. The site is not located within a mapped 100 year floodplain, and are all several feet higher in elevation than the on-site perennial stream. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject isolated wetlands. The wetlands would not be considered traditional navigable waters in that they do not have the necessary water depths to support navigation of any kind, and they do not have any surface hydrologic connection to a waterbody that would. The wetlands do not cross or serve as any state boundary and do not have a use that would associated them with interstate commerce.**
