### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Meadowbrook Road is at least ten feet higher in elevation than Wetland 2. Wetland 2 is a depression wetland that has no historic or current natural or man-made direct surface connection to any jurisdictional waters. Wetland 2 is approximately 6 feet higher in elevation than the nearest part of Wetland 1, which is about 90 feet to the southwest. The main body of Wetland 1, shown with different shading than the rest of Wetland 1 on the referenced delineation drawing, consists of inundated emergent wetlands within the active floodplain of Fish Creek. The line of different shading represents a topographic break on the site. Wetland 2 is forested, is 30 feet higher in elevation than the main body of Wetland 1, and is outside of the mapped floodplain for Fish Creek. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the Wetland 2. The wetland would not be considered a traditional navigable water in that it does not have the necessary water depths of support navigation of any kind, and it does not have any surface hydrologic connection to a waterbody that would. The wetland does not cross or serve as any state boundary and does not have a use that would associate it with interstate commerce.**
