### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- Other: (explain, if not covered above): **There are eleven (11) isolated wetlands, identified as Wetlands 7 through 16 and Wetland 20, that total 3.48 acres within the jurisdictional determination boundary. Wetlands 7 through 10 are located within the northwest portion of the site. All four of these wetlands are sloping within confined valleys, but end at their downhill termini due to increases in elevation and a loss of wetland indicators. Wetlands 9 and 10 continue off-site, but end not far outside of the property boundary where the grade increases prior to reaching a road. That road is approximately 30 feet higher in elevation than the wetlands. There are no wetlands or other waters on the opposite side of the road, nor any culverts that could connect these wetlands to any potential waters of the United States. Wetlands 7 through 10 are located a minimum of 250 feet away from the nearest jurisdictional waters. Wetlands 11 and 12 are small isolated depressions located within the northern portion of the site. They are surrounded by uplands that are five feet higher in elevation than the wetlands. Wetlands 11 and 12 are located a minimum of 170 feet from the nearest jurisdictional waters. Wetlands 13, 14, 15 and 16 are located in the eastern portion of the site, near Cold Springs Road. These wetlands appear to have formed in borrow areas. There are no roadside ditches on either side of the road that could connect these wetlands to any jurisdictional waters, nor are there any culverts beneath the road that could connect them to any jurisdictional waters. There are no wetlands or waters on the direct opposite side of Cold Springs Road as these wetlands. The ground is at least 10 feet higher in elevation on the opposite side of Cold Springs Road. These wetlands are a minimum of 120 feet from the nearest jurisdictional waters. Wetland 20 is located in the south-central portion of the site. It is a small man-induced isolated depression located near Wetland 4. An undisturbed upland area of 65 feet separates Wetlands 20 and 4. There are no natural or man-made surface connections between any of the isolated wetlands and their nearest jurisdictional waters. There is also no evidence that would suggest that these isolated waters were once physically connected to any jurisdictional waters. The site is not located within a mapped 100 year floodplain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject wetlands. The wetlands would not be considered traditional navigable waters in that they do not have the necessary waters depths to support navigation of any kind, and they do not have any surface hydrologic connection to a waterbody that would. The wetlands do not cross or serve as any state boundary and do not have a use that would associate them with interstate commerce.**
