### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

  - Other: (explain, if not covered above): **There is one (1) isolated wetland within the limits of the jurisdictional determination. The wetland is 1.67 acres in size and can be classified as palustrine emergent cover type and is located in the west/southwestern eastern portion of the site. The wetland is located approximately 1200 linear feet from the closest waterbody, an unnamed tributary to the Mohawk River, located to the west of the subject site. The wetland is encompassed by non-hydric soils and upland vegetation. No existing or historic man-made connections between the wetland and any jurisdictional waters were observed in the field or identified within the historic land use information contained within the project file. It should be noted that the surface water elevation of the adjacent water supply reservoir is at least ten (10) feet higher than that surface elevation of the wetland. The wetland is not located within a mapped 100-year floodplain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the wetland. The wetland would not be considered a traditional navigable water in that it does not have the necessary water depth to support navigation of any kind, and it doesn't have any surface hydrologic connection to a waterbody that would. The wetland does not cross any state boundary and does not have a use that would associate it with interstate commerce.**
