### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The two on-site wetlands (Wetland B and Wetland F) were determined to not be jurisdictional because they are isolated. Neither wetland showed a hydrologic connection to any waters of the U.S. The nearest water (Long Island Sound), located off-site, is approximately 750 feet south of Wetland B and 2,250 feet south of Wetland F. Also, the Byram River is

approximately 500 feet east of the site boundary. Both wetlands are lower in elevation than the surrounding areas and separated from the Sound by the New England Thruway (I-95) as well as residential and commercial development, and from the Byram River by residential and commercial development. The wetlands appear to be low areas that collect stormwater runoff from I-95 and other surrounding roads and development. There are no features within either which are or could be used by interstate or foreign travelers for recreational or other purposes. There are no areas from which fish or shellfish can be or are taken and sold in interstate or foreign commerce. Consequently, there does not appear to be a reasonable nexus with interstate commerce. Also, the use, degradation or loss of the wetlands will not affect waters of the U.S. or affect interstate or foreign commerce.
