Summarize overall biological, chemical and physical functions being performed: The wetlands appear to provide moderate wildlife habitat, water quality and groundwater recharge functions.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to carry pollutants or flood waters to TNWs, or to reduce the amount of pollutants or flood waters reaching a TNW?

- Does the tributary, in combination with its adjacent wetlands (if any), have other relationships to the physical, chemical, or biological integrity of the TNW?

This connection to Wetland 6 was severed by the construction of Wright Lane. Though not directly abutting a RPW, Wetland 4, in combination with the other eight (8) on-site wetlands, appears to provide moderate value storm water and sediment attenuation, wildlife habitat and groundwater recharge functions. During periods of high precipitation, drainage from Wetland 4 could rise to an elevation which would allow storm water exchange between it and Wetland 6 via overland flow. The functions provided by Wetland 4 protect the biological, chemical and physical integrity of the downstream tributaries, which ultimately drain to the Hudson River, a TNW.
