#### B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. empties into the Hudson River. Prior to its confluence with the Hudson River, a TNW, the Croton River itself is considered traditionally navigable (up to approximately Goose Island). On-site, a perennial tributary flows into the Kisco River from the south, and a man-made drainage course flows into the River from the north.

Summarize overall biological, chemical and physical functions being performed: Wetland C provides habitat, as well as water filtration as the Kisco River passes through this area of lower energy flow before becoming a straight channel through the rest of the site.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The on-site wetland (Wetland B on the attached drawing) considered in this jurisdictional determination was determined to not be jurisdictional because it is isolated. Wetland B is an emergent wetland in a topographically low area, dominated by reedgrass (*Phragmites australis*), poison ivy (*Toxicodendron radicans*), jewelweed (*Impatiens capensis*), summer grape (*Vitis aestivalis*), and Japanese honeysuckle (*Lonicera japonica*).

The wetland is situated at the bottom of a slope from a higher elevation parking lot. There are also stormwater drainage culverts from the parking lot that bypass the wetland to the east and the west, and flow into the Kisco River. There are two catch basins for the stormwater systems near the wetland, one on the eastern side and one on the western side. Each basin is approximately 30 feet from the wetland. During heavy enough rainfall to produce overland flow, water from the uplands surrounding the basin would flow into the basins, as their open grate tops are of lower topography than the surrounding upland areas. There are no visible signs of flow from the wetland to either basin, such as gullies, erosion, or vegetation changes. There appears to be an absence of continuous, or even regular flow, and no significant flow, if any, even during times of rain.

There are no features within the wetland which are or could be used by interstate or foreign travelers for recreational or other purposes. There are no areas from which fish or shellfish could be or are taken and sold in interstate or foreign commerce. Consequently, there does not appear to be a reasonable nexus with interstate commerce. The use, degradation or loss of the wetland would not affect waters of the U.S. or affect interstate or foreign commerce.
