C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Other: (explain, if not covered above): **There are three isolated wetlands, Wetland A, B and C, within the limits of the jurisdictional determination. Wetland A is predominantly an emergent wetland, while Wetlands B and C are predominantly forested wetlands. Wetland C continues off-site to the south, but ends approximately 200 feet south of the property boundary. All three wetlands are located more than 300 linear feet from any potentially jurisdictional wetland, which would be located outside the property boundaries. All three wetlands are entirely surrounded by upland vegetation and upland soils, and fail to show any hydrological connection to any jurisdictional waters. There are no man-made or natural discrete and/or confined surface water connections between the wetlands and any jurisdictional water of the United States. The wetlands are not located within a mapped 100-year flood plain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject wetlands. The wetlands would not be considered a traditional navigable water in that they do not have the necessary water depth to support navigation of any kind, and they don't have any surface hydrologic connection to a waterbody that would. The wetlands don't cross any state boundary and don't have a use that would associate it with interstate commerce.**
