#### A. TNWS AND WETLANDS ADJACENT TO TNWS

The portion of Penhorn Creek situated below the tide gate is a tidal tributary of the Hackensack River, a navigable water way. Pursuant to Title 33 of the Code of Federal Regulations, Section 329, the onsite adjacent wetlands, which are part of the larger surface water tributary system situated above the tide gate are considered "Navigable in Law" and are under the juridiction of the U.S. Army Corps of Engineers.

#### 2. Wetland adjacent to TNW

Summarize rationale supporting conclusion that wetland is "adjacent": The on-site wetlands met the hydrophytic vegetation, hydric soils and wetland hydrology criteria established in the 1987 "Corps of Engineers Wetlands Delineation Manual," Technical Report Y-87-1. The 0.46 acres of on-site wetlands are considered adjacent to a TNW. Therefore, the wetlands are part of the surface water tributary system of a navigable water of the United States.

## C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
