Summarize overall biological, chemical and physical functions being performed: Site and adjacent lands contain large wetland complex with seasonal RPWs. Wetlands serve as floodplains for the streams. Combined, these waters provide floodflow alteration, groundwater recharge (wetlands), production export and wildlife habitat, among others.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. Uplands were confirmed in the field to be present around the boundary of each isolated wetland. The isolated wetlands either lie within areas that were in agricultural production in the recent past or are in forested depressions. For all seven of these wetlands, there are no natural or man-made surface connections between the isolated waters and any jurisdictional waters, nor is there evidence of any disturbances that could have caused these wetlands to be disconnected from any jurisdictional waters. The wetlands are not located within a mapped 100 year floodplain. Therefore, during times of heavy participation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject isolated wetlands. These wetlands would not be considered traditionally navigable waters in that they do not have the necessary water depths to support navigation of any kind, and they do not have any surface hydrologic connection to a waterway that would.
