C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Wetland 2 becomes linear as it slopes southeast and then ceases as it lacks evidence of dominant hydrophytic vegetation, hydric soils and wetland hydrology. Wetland 2 is encompassed by uplands and there is no evidence of any past or current surface connections to any jurisdictional waters. Wetland 2 is 20 feet lower in elevation than Wetland 1 and several feet higher in elevation than Wetland 3. Wetland 2 is located at least 280 feet and 400 feet away from Wetlands 1 and 3, respectively. Wetland 2 is not located within the mapped 100 year floodplain of the Dwaas Kill, which is identified as Stream 1 on the referenced delineation map. Therefore, during times of heavy precipitation, there is a very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject isolated wetland. Wetland 2 would not be considered a traditionally navigable water in that it does not have the necessary water depths to support navigation of any kind, and it does not have any surface hydrologic connection to a waterway that would. The wetland does not cross or serve as any state boundary and does not have a use that would associate it with interstate commerce.**
