C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

With the exception of Wetland 3, the isolated wetlands are located entirely on the subject property and within the JD boundary. Wetland 3 continues off-site to the north, but ceases a short distance off of the property boundary. Off-site, the elevation rises after the wetland ends and there are no features present that would connect Wetland 3 to any jurisdictional waters. All of the isolated wetlands are encompassed by uplands that are higher in elevation in the areas between them and their nearest jurisdictional waters. Wetlands 3, 4, 5, 6 and 8 range in distances between approximately 40 feet and 461 feet from their nearest jurisdictional waters, which are wetlands. Their distances to a surface tributary are even larger. For all five of these wetlands, there are no natural or man-made surface connections between the isolated waters and any jurisdictional waters, nor is there evidence of any disturbances that could have caused these wetlands to be disconnected from any jurisdictional waters. The wetlands are not located within a mapped 100 year floodplain. Therefore, during times of heavy precipitation, which was occurring at the time of the USACE site inspection, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject isolated wetlands. These wetlands would not be considered traditional navigable waters in that they do not have the necessary water depths to support navigation of any kind, and they do not have any surface hydrologic connection to a waterway that would. The wetlands do not cross or serve as any state boundary and do not have a use that would associate them with interstate commerce.**
