### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- Other: (explain, if not covered above): **There are two isolated streams, identified as Streams SBA/SCA and SBD/SCB/SBE/SCC, and three isolated wetland areas, identified as Wetlands BB, BC and BL/CE, within the limits of the requested approved jurisdictional determination. Combined, the streams consist of 0.613 acre on-site and the wetlands consist of a total of 0.96 acre on-site. All three wetlands abut Stream SBA/SCA. Both of the streams enter the site from the east and flow toward the Schroon River to the west. Prior to reaching the river or its adjacent wetlands, the streams cease and lack a defined channel and an ordinary high water mark. Both streams flow through porous soils composed mostly of sand and small gravel and flow is often absorbed into the stream bed before any surface flow reaches the lowermost discernible part of the channel. No evidence of remnant channels or man-made disturbances were found to cause any disconnection between the streams and the nearest jurisdictional waters, which are wetlands. No evidence was found to show that flow from these streams reach the nearest wetlands. Stream SBA/SCA ends approximately 280 feet east of the nearest jurisdictional water (Wetland AC). Wetlands BB, BC and BL/CE abut Stream SBA/SCA further to the east. Stream SBD/SCB/SBE/SCC ends approximately 70 feet to the east of the nearest jurisdictional water (Wetland AC). Neither the two streams, nor the wetlands abutting Stream SBA/SCA are located within the 100 year floodplain of the nearby Schroon River. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject streams and wetlands. These streams and wetlands would not be considered traditional navigable waters in that they do not have the water depths to support navigation of any kind, and do not have a surface hydrologic connection to a waterbody that would. These waters do not cross or serve as any state boundary and do not have a use that would associate them with interstate commerce.**
