C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Other: (explain, if not covered above): **There are three (3) isolated wetlands on the site, identified as Wetlands 2, 3 and 4, which consist of a total of 0.41 acre on the site. All of these wetlands are forested, and do not extend off-site. Wetland 2 is a small depression wetland located in the western portion of the site. It is located at least 160 feet east of Wetland 5, and is 20 feet higher in elevation than Wetland 5, which is the nearest jurisdictional water. Wetlands 3 and 4 slope toward the Dwaas Kill but they cease a minimum of 90 feet west of Wetland 1 and even further from the Dwaas Kill. Both of these wetlands are also approximately 14 feet higher in elevation than the nearest jurisdictional waters. For all three of these wetlands, there are no natural or man-made surface connections between the isolated wetlands and any jurisdictional waters, nor is there evidence of any disturbances that could have caused these wetlands to be disconnected from any jurisdictional waters. The wetlands are not located within a mapped 100 year floodplain. Therefore, during times of heavy precipitation, there is a very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject isolated wetlands. These wetlands would not be considered traditionally navigable waters in that they do not have the necessary water depths to support navigation of any kind, and they do not have any surface hydrologic connection to a waterway that would. The wetlands do not cross or serve as any state boundary and do not have a use that would associate them interstate commerce.**
