C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- Other: (explain, if not covered above): **There are two isolated wetlands on the site, identified as Wetlands A and B, which consist of a total of 0.44 acres. Both wetlands are forested, and slope toward the west. Wetland A extends slightly off-site, but ceases less than 50 feet west of the property line. Wetland B does not extend off-site. Existing residences, utility rights-of-way and Easton Drive lie to the west. This development has been in place for decades. There is no piping or ditches on the site, near the site and along the roads that could convey these wetlands to a surface tributary system. No recent disturbances were found that could have caused these wetlands to become disconnected from jurisdictional waters. The nearest known jurisdictional waters are approximately 0.25 mile to the west. The wetlands are not located within a mapped 100 year floodplain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject isolated wetlands. These wetlands would not be considered traditionally navigable waters in that they do not have the necessary water depths to support navigation of any kind, and they do not have any surface hydrologic connection to a waterway that would. The wetlands do not cross or serve as any state boundary and do not have a use that would associate them with interstate commerce.**
