C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- Other: (explain, if not covered above): **There are three isolated waters on the subject 3.07 acre portion of the site. Wetlands A and C consist entirely of wetlands, whereas Wetland B consists of wetlands and a small pond. Wetlands B and C connect with each other off-site and cease a short distance to the west. A berm separates Wetland A and Wetlands B and C. The berm is likely man-made, however, this impact occurred several decades ago given the age of the trees growing on top of it. Combined, these waters total 0.27 acre. All of these waters slope toward Hutchins Road. Wetland A ceases at Hutchins Road. ORM and USGS mapping suggests that these waters were to be connected to an unnamed tributary to Kayaderosseras Creek, with the stream starting at Hutchins Road. It was found that no stream is present at this location. Rather, the south side of Hutchins Road has lands higher in elevation than the portion of the site containing wetlands. There is no culvert present beneath Hutchins Road at this location. There are no ditches along the road to convey these waters to any surface tributary system. Land elevation rises to the west. After remaining level for several hundred feet, the elevation does lower toward the east. Waters are present at least 800 feet to the east, beyond the existing homes on Hutchins Road. No physical connections between the on-site waters and these off-site waters were found. No recent disturbances were found that could have caused these waters to become disconnected from a surface tributary system. These waters are not located within a mapped 100 year floodplain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters in the subject isolated waters. These waters would not be considered traditionally navigable waters in that they do not have the necessary water depths to support navigation of any kind, and they do not have any surface hydrologic connection to a waterway that would. The waters do not cross or serve as any state boundary and do not have a use that would associate them with interstate commerce.**
