C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- Other: (explain, if not covered above): **There is one isolated water on the site, which is identified as Wetland B. Wetland B consists of 0.099 acre of open water (pond) and 0.055 acre of fringe wetlands. Wetland B is a man-made pond located in the western portion of the site and was constructed decades ago, well before the current owner purchased the property. Wetland B has no inlet or outlet, and its banks are quite steep. The pond is surrounded by forested uplands that show no signs of disturbances that could have caused Wetland B to become isolated from other jurisdictional waters. The nearest jurisdictional water is Wetland A2, which is located approximately 90 feet to the northwest of Wetland B. There is no evidence that Wetland B could have been connected to this wetland, or to Wetlands A1 and C on-site. Wetland B is not located within a mapped 100 year floodplain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters in to the subject isolated water. Wetland B would not be considered a traditionally navigable water in that it does not have the necessary water depths to support navigation of any kind, and it does not have any surface hydrologic connection to a waterbody that would. Wetland B does not cross or serve as any state boundary and does not have a use that would associated it with interstate commerce.**

C. SIGNIFICANT NEXUS DETERMINATION
