Summarize overall biological, chemical and physical functions being performed: This stream and wetland system receive runoff through an extended enclosure from a drainage area of approximately 21 acres. Land use within this area is roughly 50% residential and 50% golf course. Within the project area the stream buffer is 50 ft on the left descending bank and 250 ft on the right descending bank. At the bottom of the project area, the stream dissipates through the 0.16 acre common reed/green ash wetland which formed in an artificial and abandoned pond. The stream exits the project area through a second extended enclosure and discharges to Lake Tappan, approximately 0.36 river miles below the project area. This system likely filters nutrients from runoff and provides minimal habitat.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:**
