### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

- Other: (explain, if not covered above): **There are three isolated wetlands and one isolated stream on the referenced**

**delineation map within the limits of jurisdictional determination. These aquatic resources are identified as Wetland B (0.36 ac), Wetland C (0.16 ac), Wetland E (0.14 ac), and Stream 1 (656 lf). Each of these aquatic resources is located entirely within the subject property. Wetland B is located in the northeastern section of the property and contains two wetland areas that are connected via an undefined ditch with no bed, bank, or ordinary high water mark. Based on observations made in the field Wetland B does not have any direct hydrological surface connection to any other aquatic resources and is confined by topography. The closest jurisdictional aquatic resource is located over 1,000 feet away from Wetland B. Wetland C is located in a "finger" that juts out from the northeastern corner of the property. Wetland C contains the source of the intermittent stream, Stream 1, which terminates into a farm field approximately 650 feet from the wetland without connecting with any other aquatic resource. Based on observations made in the field neither Wetland C nor Stream 1 have any direct hydrological surface connection to any other aquatic resources. On its northern, eastern, and western boundaries, Wetland C is surrounded by higher elevations, creating a bowl like depression in which the wetland is situated within. The closest jurisdictional aquatic resource is located over 1,000 feet away from Wetland C and Stream 1. Wetland E is located in the eastern portion of the property. Based on observations made in the field, Wetland E does not have any direct hydrological surface connection to any other aquatic resources. Wetland E is located alongside a hillside to its east that abruptly terminates in a depression. Slightly higher elevations to the west confine this wetland. The closest jurisdictional aquatic resource is located over 1,000 feet away from Wetland E. There are no natural or man-made surface features that connect any of these four aquatic resources with any jurisdictional aquatic resources. Neither these aquatic resources, nor the site they are located on, are located within the mapped 100 year floodplain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject wetlands or the subject stream. These aquatic resources would not be considered traditional navigable waters in that they do not have the necessary water depths to support navigation of any kind, and they do not have any hydrological surface connection to a waterbody that would. These aquatic resources do not cross or serve as any state or international boundary, and they do not have a use that would associate them with interstate commerce.**
