**SECTION II: SUMMARY OF FINDINGS**

**A. RHA SECTION 10 DETERMINATION OF JURISDICTION.**

There **Are** "*navigable waters of the U.S.*" within Rivers and Harbors Act (RHA) jurisdiction (as defined by 33 CFR part 329) in the review area. [Required]

Explain: The wetland and ditch located within the site are part of a surface water tributary system that drains to Rutherford Ditch a tidal tributary of Berry's Creek. Berry's Creek is a tidal tributary of the Hackensack River, a navigable waterway. The subject wetland and ditch are situated behind an existing tide gate, that is located within Rutherford Ditch. This tide gate is located approximately 1,200 feet south of the site, and the portion of Rutherford Ditch situated below the tide gate is a tidal. Pursuant to Title 33 of the Code of Federal Regulations, Section 329, the onsite waters of the United States are considered "Navigable in Law" and are under the jurisdiction of the U.S. Army Corps of Engineers.

### SECTION III: CWA ANALYSIS

#### A. TNWs AND WETLANDS ADJACENT TO TNWs

The agencies will assert jurisdiction over TNWs and wetlands adjacent to TNWs. ##### 1. TNW

Summarize rationale supporting determination: The on-site waters of the United States, including wetlands, are located above an existing tide gate. This tide gate is situated within Rutherford Ditch approximately 1,200 feet south of the site. The portion of Rutherford Ditch situated below the tide gate is a tidal, and drains to Berry's Creek, a tidal tributary of the Hackensack River, a Traditional Navigable waterway. Pursuant to Title 33 of the Code of Federal Regulations, Section 329, the onsite waters of the United States and associated adjacent wetlands are considered "Navigable in Law" and are under the jurisdiction of the U.S. Army Corps of Engineers.

##### 2. Wetland adjacent to TNW

Summarize rationale supporting conclusion that wetland is "adjacent": The on-site wetlands met the hydrophytic vegetation, hydric soils and wetland hydrology criteria established in the 1987 11Corps of Engineers Wetlands Delineation Manual, " Technical Report Y-87-1. The 1.197 acres of wetlands, which includes Wetland Area A, is considered adjacent to a Traditional Navigable Waterway (TNW). Therefore, the wetlands are part of the surface water tributary system of a navigable water of the United States.

#### B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody<sup>4</sup> is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. If the JD covers a tributary with adjacent wetlands, complete Section III.B.1 for the tributary, Section III.B.2 for any onsite wetlands, and Section III.B.3 for all wetlands adjacent to that tributary, both onsite and offsite. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
