The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Wetland A is located in the central southern area of the property in close proximity to an existing developed area and U.S. Route 9W at the top of a hill in a flat area. The western portion of the wetland terminates in a steep hillside that abuts an upland area that is densely forested, mainly with eastern white pines. Based on observations in the field, Wetland A does not have any direct hydrological surface connection to any other aquatic resource. The closest jurisdictional aquatic resource is over 200 feet away from Wetland A. There are no natural or man-made surface features that connect Wetland A with any jurisdictional aquatic resource. Neither Wetland A, nor the site it is located on, is located within the mapped 100 year floodplain. Therefore in times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject wetland. Wetland A would not be considered a traditional navigable water in that it does not have the necessary water depths to support navigation of any kind, and it does not have a hydrologocial connection to any waterbody that would. Wetland A does not cross or serve as any state or international boundary, and it does not have a use that would associate it with interstate commerce.**
