C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- Other: (explain, if not covered above): **There are two wetland areas, identified as Wetlands D and E, that total 0.07 acre within the 29.01 acre portion of the property in which an approved jurisdictional determination (JD) is being requested. On August 22, 2014, the New York District of the USACE issued an approved JD for this property, in which it was determined that these two wetlands are isolated, intrastate waters and not subject to USACE jurisdiction in light of the U.S. Supreme Court decision (SWANCC). A subsequent USACE site inspection conducted on August 28, 2019, confirmed that the delineation of these two wetlands, along with their characteristics, remains the same. Both Wetlands D and E are in close proximity to each other and are depicted on Sheet 2 of 3 of the wetland delineation drawings. Both wetlands are located entirely within the JD limits and do not extend off-site. Both wetlands are emergent and are depressions located in areas previously used for agriculture. Wetlands D and E are located a minimum distance of 160 feet from the nearest jurisdictional waters, which are wetlands. There are no natural or man-made discrete or confined surface hydrological connections between Wetlands D and E and any jurisdictional waters. Both wetlands are surrounded by uplands and there is no evidence of any historic disturbances that could have caused these wetlands to become disconnected from any waters of the United States. There also does not appear to be any potential for ecological interconnections or shallow subsurface flow between the isolated wetlands and their nearest jurisdictional waters. The site is not located within a mapped 100 year floodplain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject wetlands. The wetlands would not be considered traditional navigable waters in that they do not have the necessary water depths to support navigation of any kind, and they do not have any surface hydrological connection to a waterbody that would. The wetlands do not cross or serve as any state boundary and do not have a use that would associate them with interstate commerce.**
