C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

F. NON-JURISDICTIONAL WATERS, INCLUDING WETLANDS (CHECK ALL THAT APPLY):

Other: (explain, if not covered above): **There is one isolated wetland, identified as Wetland A, with a total of 0.12 acre within the jurisdictional determination boundary. Wetland A is located approximately 590 feet west of the nearest jurisdictional tributary, a perennial stream located just off-site to the east. Wetland A is 7 feet higher in elevation than the nearest stream and the stream and Wetland A are separated by a ridge. Wetland A also slopes to the west, which is away from the stream. A small portion of Wetland A extends off-site to the south but the terminus of the wetland in this direction was evident during the USACE site inspection. Wetland A is surrounded by uplands that have not been manipulated to cause it to become disconnected from any jurisdictional waters. There are no natural or man-made discrete or confined surface hydrological connections between the isolated wetland and any jurisdictional waters. Wetland A and the subject property are not located within a 100 year floodplain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject wetland. The wetland would not be considered a traditional navigable water in that it does not have the necessary water depths to support navigation of any kind, and it does not have any surface hydrologic connection to a waterbody that would. The wetland does not cross or serve as any state boundary and does not have a use that would associate it with interstate commerce.**
