C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

Overall this period is considered to fall within normal climatic conditions. However, the Palmer Drought Severity Index indicates mild drought during this period, the WebWIMP indicates this period fell within the wet season, and the 30-days preceding the delineation were generally “normal” (within the 30-year normal range for the majority of the month).

The NRCS Web Soil Survey indicates that flooding frequency for the majority of the site is “None,” which means that flooding is not probable (the chance of flooding is nearly 0 percent in any year and flooding occurs less than once in 500 years). The subject parcels are identified as having gravelly silt loam soils, which are well drained.

Rockland County GIS’s two-foot topographic contour lines indicate the site is relatively flat. The USFWS National Wetland Inventory Map indicates one forested freshwater wetland and a small portion of the East Branch Hackensack River channel within the subject parcel. Aerial imagery and historic maps show the historic channel alignment, which included a small wetland abutting the subject parcels, ran along the path that is present-day Corporate Drive. It appears the East Branch Hackensack River channel was rerouted around the western side of the existing buildings on Corporate Drive sometime between 1955 and 1967. The 1967 historic USGS map shows the channel passing through the parcel before making a sharp turn to the west. Though Wetland C is geographically closer to the East Branch Hackensack River than Wetland A, there is no hydrologic connection to the tributary or other wetlands. The pipe that conveys water from Wetland A remains underground for the length of the pipe and does not connect to Wetland C. A broken pipe was observed in the vicinity of Wetland C; however, this pipe does not connect to the pipe from Wetland A. The topography between Wetland A and Wetland C is generally flat with a small swale that does not have markers of a hydrologic connection. Photographs of the area following a rain event show no surface water flow in the area. Similarly, Wetland D is not hydrologically connected to the tributary or other wetlands. There are no historic paths from the parcel to the wetlands east of Ridge Road; therefore, it is reasonable to conclude that Wetland E was formed from water impounded along NY-Route 303. The pipe observed along NY-Route 303 appears to be part of the municipal storm water drainage system.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

Overall this period is considered to fall within normal climatic conditions. However, the Palmer Drought Severity Index indicates mild drought during this period, the WebWIMP indicates this period fell within the wet season, and the 30-days preceding the delineation were generally “normal” (within the 30-year normal range for the majority of the month).

The NRCS Web Soil Survey indicates that flooding frequency for the majority of the site is “None,” which means that flooding is not probable (the chance of flooding is nearly 0 percent in any year and flooding occurs less than once in 500 years). The subject parcels are identified as having gravelly silt loam soils, which are well drained.

Rockland County GIS’s two-foot topographic contour lines indicate the site is relatively flat. The USFWS National Wetland Inventory Map indicates one forested freshwater wetland and a small portion of the East Branch Hackensack River channel within the subject parcel. Aerial imagery and historic maps show the historic channel alignment, which included a small wetland abutting the subject parcels, ran along the path that is present-day Corporate Drive. It appears the East Branch Hackensack River channel was rerouted around the western side of the existing buildings on Corporate Drive between 1955 and 1967. The 1967 historic USGS map shows the channel passing through the parcel before making a sharp turn to the west. Wetland A, located at the southeastern property boundary, drains to a pipe in the center of the wetland area, which conveys water west toward the East Branch Hackensack River channel. The pipe appears to trace the path of a historic tributary to the East Branch Hackensack River, visible on the Google Earth aerial dated 2003.
