Explain: **Wetland D-25 is 18.32 acres in size and can be classified primarily as a palustrine emergent (PEM) complex with some palustrine forested (PFO) portions. Drainage within Wetland D-25 flows north and enters Stream Channel**

1, which flows northeast approximately 130 feet and then enters a sinkhole. The closest jurisdictional water of the United States to Wetland D-25 and Stream Channel 1 is the Feuri Spruyt, which is located approximately 0.5 mile from the point where Stream Channel 1 enters the sinkhole. Upwelling was observed within the Feuri Spruyt during the site inspection conducted by this office. The presence of this upwelling indicates that a subsurface connection between Wetland D-25 and the Feuri Spruyt is likely. However, there is no evidence of any existing or historic man-made or natural surface water connections between Wetland D-25 and the Feuri Spruyt or any other jurisdictional waters. Further, Wetland D-25 is not located within a mapped 100-year floodplain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary to flow from other jurisdictional waters into Wetland D-25. In addition, Wetland D-25 would not be considered a traditional navigable water in that it does not have the necessary water depth to support navigation of any kind and does not have any surface hydrologic connection to a waterbody that would. Wetland D-25 does not cross any state boundary and does not have a use that would associate it with interstate commerce..

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
