Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.

Explain: **Wetlands e, f, g, h, l, and k, are isolated wetlands that reside upon shallow bedrock aquitards that trap water and are the result of soil compaction and disturbance from vehicular maneuvers. The surrounding landscape consists of broad, relatively flat training areas with similarly tight soils, shallow to bedrock. These wetlands appear to be**

isolated from the tributary system and have no significant nexus to the tributary system that would make them jurisdictional. These wetlands are at least 25 feet from the nearest potentially jurisdictional wetlands, which cross Flick Rd in several places. The closest water bodies are two unnamed tributaries to Beaver Meadow Creek, which are over 700 feet west of these wetlands, and are situated approximately 20 feet below the elevation of the wetlands. Given the separation distance and the elevation change, the wetlands would not be considered neighboring, or otherwise providing any measurable benefit to the biological, physical, or chemical quality of the intermittent tributaries or any other water of the United States. No evidence of any current connections between these wetlands and any other surface waterbody was observed. There is no evidence of a man-made or natural discrete and/or confined surface water connection between the wetlands and any other potentially jurisdictional water. The wetlands would not be considered traditional navigable waters in that there is no evidence these wetlands have the necessary water depth to support navigation of any kind or with reasonable improvements could be made to support navigation, nor have any surface hydrologic connection to a waterbody that would. The wetlands do not cross any state boundary and do not appear to have a use that would associate them with interstate commerce.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:**
