C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

F. NON-JURISDICTIONAL WATERS, INCLUDING WETLANDS (CHECK ALL THAT APPLY):

If potential wetlands were assessed within the review area, these areas did not meet the criteria in the 1987 Corps of Engineers Wetland Delineation Manual and/or appropriate Regional Supplements.

Other: (explain, if not covered above): **There are two isolated wetlands, identified as Wetlands 4 and 5, that total 0.22 acre within the subject site boundary. Both wetlands lie entirely within the site boundary and are surrounded by upland forest. Wetland 4 has no natural or artificial surface connections to any of the on-site jurisdictional waters, notably Stream 3 and Wetland 3, which are the closest to Wetland 4 and in the same drainage area. Wetland 5 has a linear wetland that extends to the east to a roadside ditch along Dunsbach Road, which lies just outside of the property boundary. The ditch at this location was constructed in uplands, and lies at a much higher elevation than Wetland 3 toward where the ditch drains. The roadside ditch did not contain any standing or flowing water during any of the inspections conducted by the consultants and the USACE, and lacks an ordinary high water mark and wetland characteristics. There are no culverts beneath the road in this area that could connect Wetland 5 to any off-site jurisdictional waters. Wetland 5 has no natural, and no other artificial surface connections to any of the on-site jurisdictional waters, including Stream 3 and Wetland 3, which are the closest to Wetland 5 and in the same drainage area. Both Wetlands 4 and 5 are approximately 10 feet higher in elevation than Stream 3, and are at least 505 feet and 804 feet away from Stream 3, respectively. Wetlands 4 and 5 are also 7 and 8 feet higher in elevation than Wetland 3, respectively. There are also no signs of any disturbances that could have caused Wetlands 4 and 5 to become disconnected from any jurisdictional waters. Wetlands 4 and 5 are not located within a 100 year floodplain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject wetlands. The wetlands would not be considered traditional navigable waters in that they do not have the necessary water depths to support navigation of any kind, and they do not have any surface hydrologic connection to a waterbody that would. The wetlands do not cross or serve as any state boundary and do not have a use that would associate them with interstate commerce.**
