C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

F. NON-JURISDICTIONAL WATERS, INCLUDING WETLANDS (CHECK ALL THAT APPLY):

If potential wetlands were assessed within the review area, these areas did not meet the criteria in the 1987 Corps of Engineers Wetland Delineation Manual and/or appropriate Regional Supplements.

Other: (explain, if not covered above): **There are five (5) isolated wetlands, identified as Wetlands A, B, C, D and F, within the jurisdictional determination boundary, which total 1.29 acres. Wetlands A and D extend outside of the JD boundary and Wetlands B, C and F and located entirely within the JD boundary. The USACE previously issued an approved jurisdictional determination for this site and additional lands on January 19, 2015, in which it was determined that these wetlands were isolated and not subject to USACE jurisdiction. Wetland A is located approximately 1,300 feet north of the nearest jurisdictional tributary and is separated from the stream by a ridge. Wetland A slopes to the southwest and ends abruptly due to a natural rise in elevation. Wetland B is 1,680 feet from the nearest jurisdictional tributary and is approximately 36 feet higher in elevation than this stream. Wetland C is 1,520 feet north of the nearest jurisdictional tributary and is 34 feet higher in elevation than this stream. Wetlands B and C are small wetlands located in the north-central portion of the side, are relatively flat and are surrounded by forested uplands. Wetland D is 2,110 feet north of the nearest jurisdictional tributary and is 16 feet higher in elevation than this stream. Wetland D slopes toward Cold Springs Road. The wetland does not reach any roadside ditch, nor are there ditches along the road to connect this wetland to any jurisdictional waters. There are no culverts beneath the road in this location, nor any wetlands or other potential waters of the United States on the east side of the road. Wetland F is 1,550 feet east of the nearest jurisdictional tributary and approximately 10 feet higher in elevation than this stream. Wetland F slopes to the south, but ceases on-site where evidence of wetland vegetation, soil and hydrology cease. There are no man-made or natural surface water connections between Wetland A, B, C, D and F and any jurisdictional waters of the United States. There is no evidence of any disburances that could have caused these wetlands to become disconnected from their nearest jurisdictional waters. Wetlands A, B, C, D and F are not located within a mapped 100 year floodplain. Therefore, during times of heavy precipitation, there is very low probability that floodwater would reach an elevation necessary for water to flow from other jurisdictional waters into the subject wetlands. The wetlands would not be considered traditional navigable waters in that they do not have the necessary water depths to support navigation of any kind, and they do not have any surface hydrologic connection to a waterbody that would. The wetlands do not cross any state boundary and do not have a use that would associate them with interstate commerce.**
